**DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**Mixing:**

Fill sprayer tank with half the required amount of water, add the full amount of AXXE Broad Spectrum Herbicide to be used (see Dilution Factors below), then fill the sprayer tank with the remainder of the water required for the desired final concentration. Since AXXE Broad Spectrum Herbicide is completely soluble in water and when uniformly dispersed in water, continuous mixing or agitation is not required.

Always pre-determine the compatibility of labeled tank mixes of AXXE Broad Spectrum Herbicide with other products in advance of application. When tank mixing, add formulation in the following sequence: compatibility agent (if needed), wetting agent and soluble powders, flowable liquids, emulsifiable concentrates and AXXE Broad Spectrum Herbicide. Mix only with other labeled products.

**Dosage and Application Rates:**

When mixing AXXE Broad Spectrum Herbicide with systemic herbicide(s) use a 1.5-3% V/V (Volume/Volume) application rate alongside systemic herbicide's labelled rates. Apply AXXE Broad Spectrum spray solutions only when weed surfaces are dry. Spray for coverage of unwanted vegetation. AXXE Broad Spectrum Herbicide is a non-selective, post-emergent contact herbicide.

Repeat spray applications as necessary to obtain the desired control or suppression of weeds from newly germinated weed seeds and regrowth from roots or stems.
